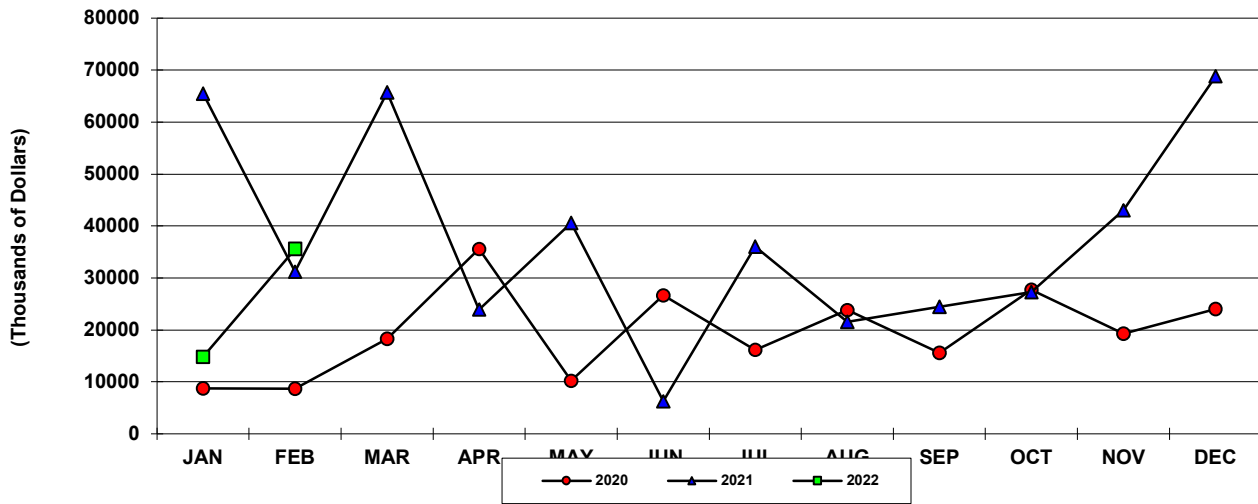

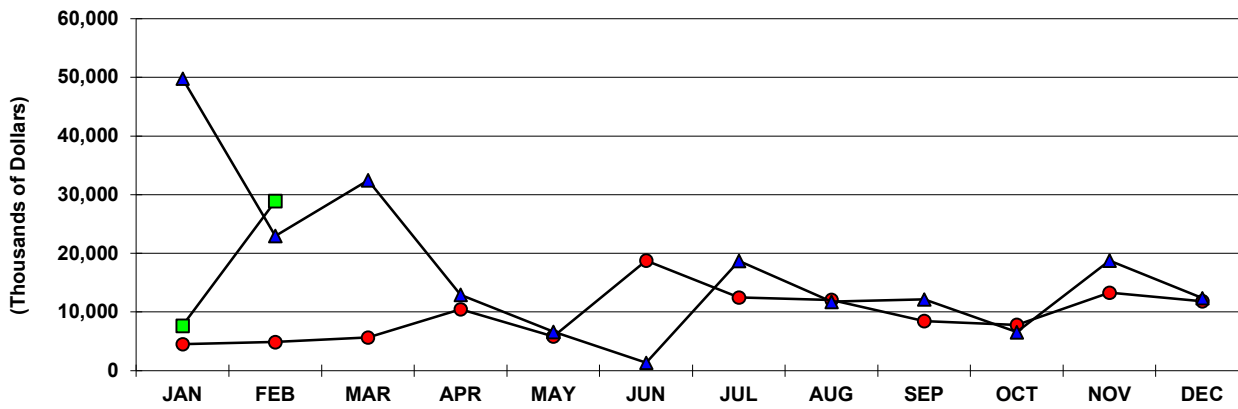

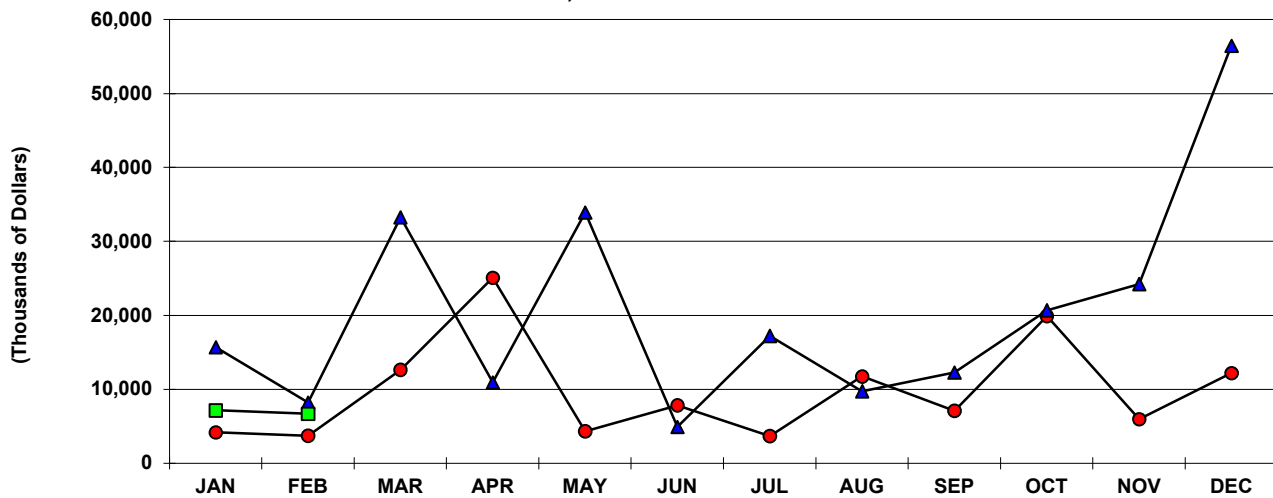
**U.S.V.I. TOTAL PERMIT VALUE

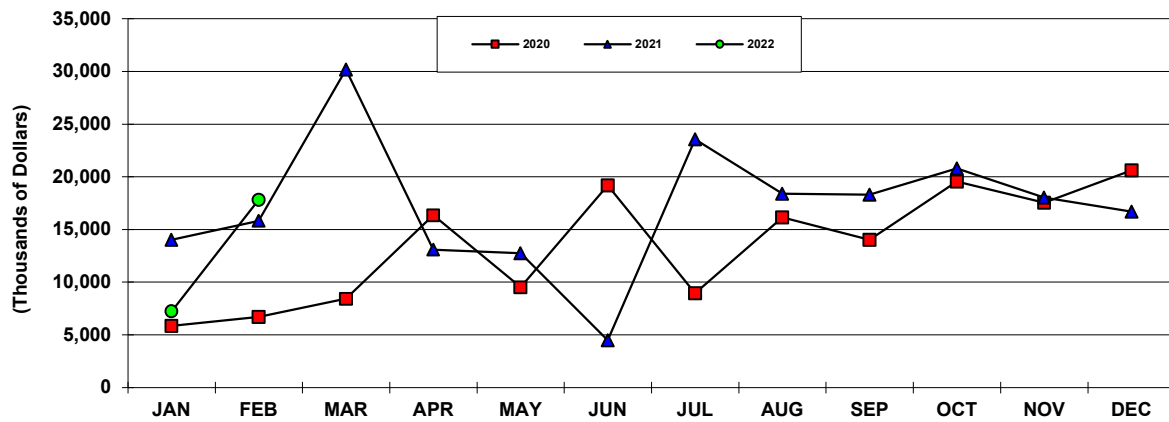

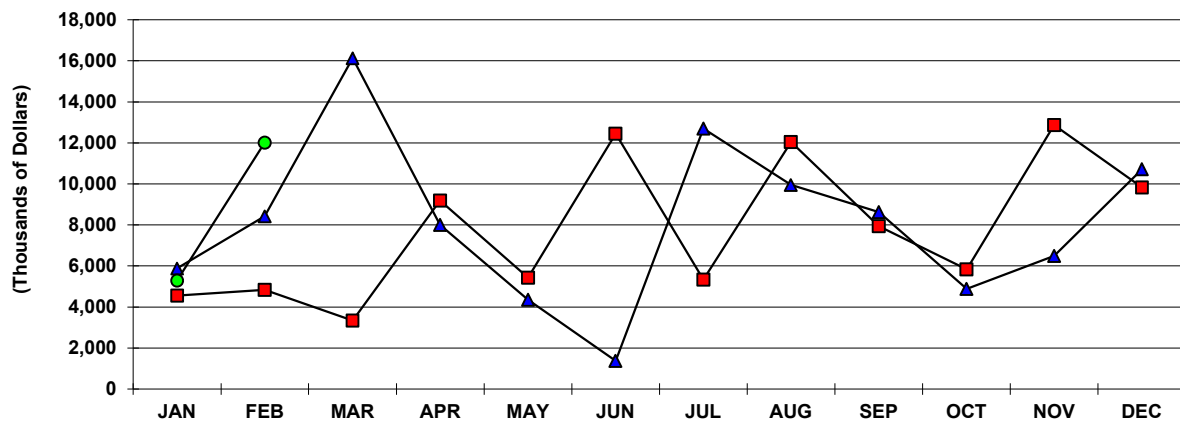

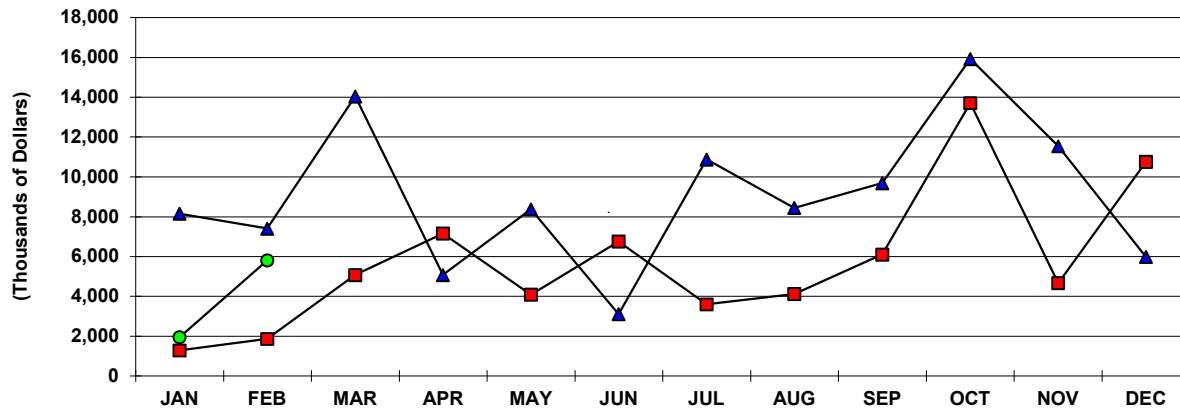
U.S.V.I PRIVATE RES. PERMIT VALUE
