#### Total visitors arrivals fell by 10.3 percent in June 2009

In June, there was a 10.3 percent decline in total visitors which numbered 150,048 compared to 167,325 in June of 2008. The number of air visitors fell by 7.4 percent to 58,110 from 62,779 in June 2008. Cruise passenger arrivals fell 12.1 percent to 91,938 from 104,546 a year earlier, partly as a result of the loss of cruise calls this summer from the Mariner of the Seas.

#### Arrivals by District

The St. Thomas and St. John district experienced a decline of 10.5 percent in air visitors to 46,558 from 52,022 last June. Conversely, the district of St. Croix experienced its third consecutive month uptick in air arrivals, posting a 7.4 percent increase in air visitors from 10,757 to 11,552. The district's recent increase in air passenger activity can be attributed to additional American Eagle and Delta flights to St. Croix.

The St. Thomas and St. John district received 91,938 cruise passengers or 12.1 percent less than last year. St. Croix hosted 6,758 cruise passengers this month. There were no cruise ship visitors to St. Croix a year earlier. Overall, 28 cruise ship calls were recorded for June 2009 compared to the 32 port calls made in June 2008.

## **Hotel Occupancy**

The Territory's reported hotel occupancy rate for June 2009 averaged 57.0 percent compared to 63.3 percent for the corresponding month in 2008. The rate for St. Croix was 36.6 percent compared to 50.0 last June. The rate for St. Thomas and St. John was 63.8 percent compared to 67.9 percent a year ago. Territory-wide occupied room nights were 81,567 compared with 92,695 the previous year. A total of \$1,371,986 was collected in hotel room revenues this June compared to \$1,447,817 in June 2008, a 5.2 percent decline in revenue.

#### **Tourism Statistics January to June 2009**


A total of 1,249,672 visitors arrived in the Territory during the first six months of 2009, a 12.9 percent decline or 184,513 fewer visitors than the corresponding period in 2008. There were 366,939 air visitors or 8.4 percent less than the 400,776 air visitors for the same six-month period in 2008. June 2009 year-to-date cruise passengers arrivals were 882,733 versus 1,033,409 one year earlier. There were 366 cruise ship calls during this period, 13.1 percent less than last year.

The hotel occupancy rate averaged 60.7 percent for this period. There were 470,285 registered hotel guests. Guests from the United States showed a 2.6 percent year-on-year increase. Local resident guests climbed by 14.5 percent, while guests from Puerto Rico decreased 12.9 percent. Guests from Other Areas and Other West Indies increased by 40.7 percent and 19.3 percent, respectively. Guests from Central and South America declined by 50.3 percent and 10.3 percent, respectively. Conversely, guests from Europe increased by 15.3 percent, and Canadian guests grew by 30.3 percent.




